

# [THE MEYDAN FAMILY FOUNDATION RAFFLE]

## TERMS AND CONDITIONS OF ENTRY

1. By entering into this competition, you (the **Player**) accept these terms and conditions.
2. The entity facilitating the competition is Formware Pty Ltd (ACN 053 885 644) (**Formware**) on behalf of the Meydan Family Foundation Ltd (ACN 153 682 298) (**Foundation**) and the name of the competition is “[The Meydan Family Foundation Raffle]” (**Raffle**).
3. The Foundation is a Community and Charitable Organisation in Victoria (dec no 58487), as declared by the Victorian Commission for Gambling and Liquor Regulation pursuant to the *Gambling Regulation Act 2003* (Vic) (**Act**).
4. The Raffle is permitted under section 8.2.3 of the Act, with the value of prizes being no more than \$5000.
5. All net proceeds from the Raffle will be paid by the Foundation to local charities.
